## To the Membership:

In 2005, two bills were being considered by the House of Representatives that may impact all of the military services and educational institutions which serve them. Synopses of H.R. 269 and H.R. 1207 are listed below.

### Synopsis of H.R. 269

To amend title 38, USC, to provide for certain active duty servicemembers to become eligible for educational assistance under the Montgomery GI Bill.

Short Title: "Montgomery GI Bill Enhancement Act of 2005"

Will allow active duty personnel who first entered on active duty before July 1, 1985, to contribute \$2,700 within a period of 18 months from the date the individual makes an election under this bill.

### Synopsis of H.R. 1207

To amend title 38, USC, to provide additional work-study opportunities for eligible veterans and for other purposes.

Short Title: "Department of Veterans Affairs Work-Study Act of 2005"

Additional areas of work study for veterans: Provision of counseling and assistance

in identifying employment and training opportunities to members of the Armed Forces who are being separated and spouses of such members; and support of Senior ROTC programs.

Ten percent of all work-study agreements may be for a 5-year pilot program for on-campus work-study positions available on site at educational institutions. May include positions in academic departments (such as tutors or research, teaching, and lab assistants) and in student services (such as career centers, financial aid, campus orientation, cashiers, admissions, records and registration).

**Status as of 7/25/06:**

H.R. 269 was referred to the House Subcommittee on Economic Opportunity on 4/4/05.

H.R. 1207 was referred to the House Subcommittee and hearings held on 5/25/05

No further action was reflected on the Congressional site for these pending bills.

## From Monterey County



Described as the greatest meeting of land and sea, Monterey County encompasses some of California's most stunning scenery while offering world-renowned Monterey attractions and recreation. From the dramatic Big Sur coastline to romantic Carmel and Pebble Beach, to historic Monterey with its diverse peninsula communities, to the fertile Salinas Valley, Monterey County offers a rich and complete variety of destinations for the leisure or the business traveler. A first time trip to Monterey County should include such sites as the Monterey Bay Aquarium, Cannery Row, Fisherman's Wharf, 17-Mile Drive, National Steinbeck Center, Elkhorn Slough and Monterey Wine Country. Listed in this newsletter are details on the aquarium, wharf and 17-mile drive. See the April 2006 newsletter for details on Cannery Row and wine tasting.

### MONTEREY BAY AQUARIUM

Discover life in Monterey's bay without leaving dry land at the Monterey Bay Aquarium. Dedicated to marine research and conservation, the Monterey Bay Aquarium is known throughout the world for its interactive exhibits and ability to present marine life on a truly grand scale. You might begin your tour in the Aquarium's matchless near-shore and coastal exhibits that explore the habitat and ecosystem of creatures of the tide-pools, then go on to the Outer Bay exhibit, showcasing hammerhead sharks, schools of sardines, enormous sun fish and green sea turtles. Kids love the "Splash Zone", featuring kid-sized exhibits, South African penguins, and

much more. The most spectacular new exhibit is Jellies: Living Art, a splendid combination of rare and delicate jellies and fine art. Don't miss feeding time in the giant kelp forest exhibit or the sea otter tank!

### FISHERMAN'S WHARF

Old Fisherman's Wharf in downtown Monterey should be on the "must-do" list of every visitor to the area. This is a great place to take in the sights and sounds and smells of Monterey. Because neighboring Wharf 2 is the heart of the area's thriving fishing industry, where



you can usually watch the working trawlers unloading the catch of the day — just look for all of the seagulls hoping for a handout to know who's had a successful day on the Bay! Stroll down the wharf with a cup of hot clam chowder, or stop by one of several restaurants featuring fresh Monterey Bay seafood. You can photograph sea lions and otters frolicking in the calm inner harbor waters, or if you're feeling more adventurous, take to the waters with a glass bottom boat tour, deep-sea fishing trip or whale watching tour in season.

### 17-MILE DRIVE

Seventeen miles of sea and sky, immaculate golf courses, and dream homes set graciously behind elegant gates. This is the essence of Pebble Beach's 17-Mile Drive. Shepherd's Knoll looks out over Monterey Bay and



the Gabilan Mountains. Huckleberry Hill, at a high elevation, is known for its native huckleberry bushes. Spanish Bay is a great place to take a walk along the links. Other golf courses include Poppy Hills, Spyglass and Pebble Beach, home of the AT&T Pebble Beach National Pro-Am. The bleached branches of the Ghost Tree rise eerily above the sea. Point Joe and the Restless Sea, where all too many early sailors were wrecked, remind visitors that the sea is a force to be reckoned with. The Cypress Point Lookout (closed April 1-June 1) offers magnificent views of the Big Sur coastline. The Lone Cypress is a 200 year-old tree whose tenacious hold on the rocks has inspired artists. The Pebble Beach Equestrian Center holds annual equestrian events and is the starting point for guided trail rides. There are opportunities to picnic at several locations. Five gates give entry to 17-Mile Drive; the price is \$8.75 per car.

### RESTAURANTS

Monterey County is home to hundreds of delightful places to eat — from casual family-oriented cafes to elegant, award-winning restaurants, and every kind of eatery in between — so don't leave home without your appetite.

#### The Grill on Ocean Avenue

..... is one of the Monterey Peninsula's 10 best restaurants, as named by Epicurean Rendezvous Restaurant Guide and the Monterey County Critics Choice list. The cuisine is lyrical, clearly California in its freshness and lightness with Pacific Rim influence.

#### Flaherty's

..... is home to two restaurants: the casual and lively Oyster Bar and our relaxing dinner house, the Seafood Grill. In a bright and lively atmosphere, Flaherty's offers fresh regional and specialty fishes including local sand dabs, Monterey Bay spot prawns, live oysters and live whole cracked dungeness crab. Flaherty's also offers homemade pastas, meat and poultry, and award-winning Manhattan and New England clam chowders.
